Affordability and Financial Management			
The Long-Term Plan (LTP) 2024–2034 outlines average rates increases totalling 115% over 10 years. If (re)elected, would you support these planned increases? If not: What level of average annual increases would you consider acceptable instead?		Did not provide a "yes" or "no" answer, or a percentage figure. States that the LTP was the best job the current Council could do, and hopes the new Council can do better to slow down rates increases.	Candidate Young has chosen to answer all of the questions this way: <i>"I note that Concerned Ratepayers is a group with no formal membership, supporting specific candidates, including one standing directly for the Raumati and Paekākāriki Ward. As such you are part of another group of candidate's electioneering. I therefore have little confidence that it is appropriate that your organisation runs 'Meet the Candidate Meetings' or ask other candidates to answer your questions. Many of your questions appear to be loaded, and I have chosen to provide responses that I consider are suitably appropriate for you to include in their entirety – including all of this text.</i>
The LTP plans to spend an average of \$3.1 million per year on "economic development" over the next decade, mostly funded by residential rates. Would you support continuing this level of spending?		Did not provide a "yes" or "no" answer. Answer outlines a concern the spending as "being somewhat aimless" and should be an area that the next Council reviews. Should be wary of making major decisions in this area right now.	<i>Few enjoy paying Rates, but we have to leave Kāpiti in a better state than before. My commitment is to set rates with the same scrutiny we apply to our money. There are 'must haves', but also 'extras' that make Kāpiti the unique and beautiful place we love - our parks, libraries, pools and even some events and groups. Let's deliver what's important and not fund things that aren't.</i>
Funding to the Toi Mahara gallery increased from \$218,600 in 2022/23 to \$671,300 in 2025/26—a 207% rise. Would you support this level of funding continuing over the next three years?		Did not provide a "yes" or "no" answer. KCDC plans to reduce its debt from a peak of \$345 million (in 2030) to \$262 million by 2034, largely funded through higher rates. Do you support this debt reduction strategy?		Answer outlines the pros and cons of the current KCDC plan, including impact on rates but creating a buffer in the event of a natural disaster. Suggests the next Council "digs deep" into whether to continue with debt reduction.
